1. Rebates on Control on Fertilizer/Granules will be paid ONLY on quantities verified using EDI data. No invoice submissions will be accepted.
2. Products in the matching program are considered "different products" and not just 2 or more of the same product.
3. Any rebates submitted and verified by February 1, 2022 will be paid by May 2022. Any rebates submitted and verified by October 31, 2022 will be paid by December 31, 2022.
4. Qualifying products must be invoiced October 1, 2021 - September 30, 2022. EOP 1 is October 1 - December 31, 2021. EOP 2 is January 1 - February 28, 2022.
5. You must submit your Rebate Form online with the exception of the Control Products on Fertilizer/Granules (will be paid via EDI). You can upload your invoices, if required, or mail them along with a copy of your completed submission to the address below. **Invoices must be uploaded or mailed with a postmark date of no later than October 31, 2022:**
